### Typical Inductance vs. Current Characteristics:

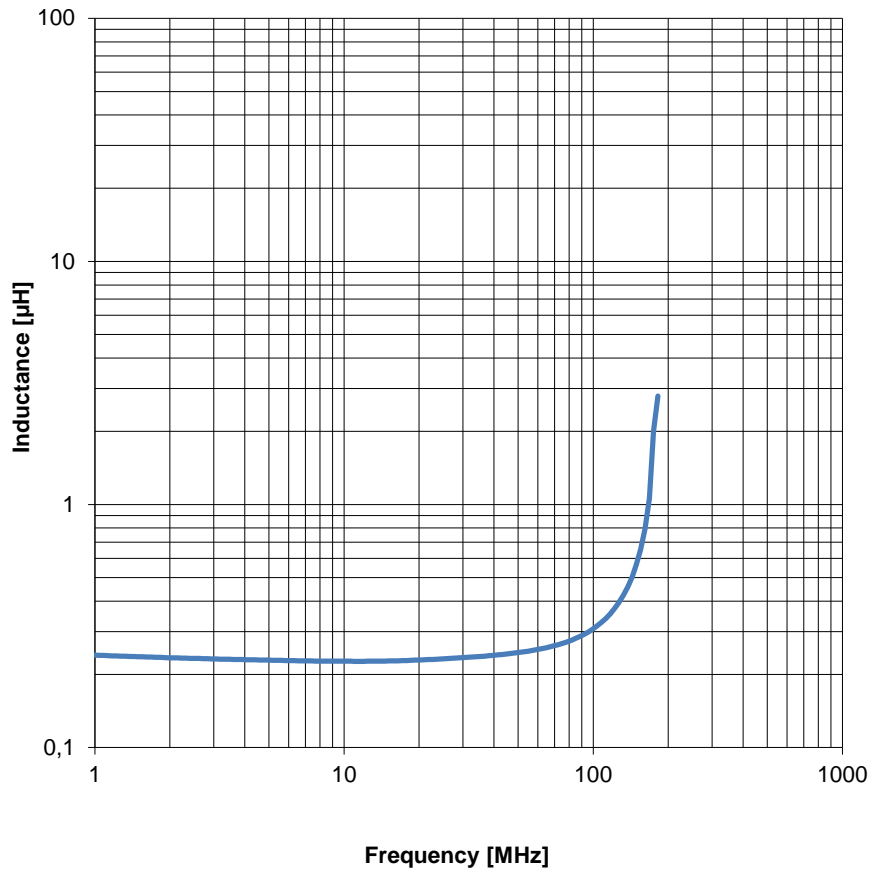



### Typical Temperature Rise vs. Current Characteristics:

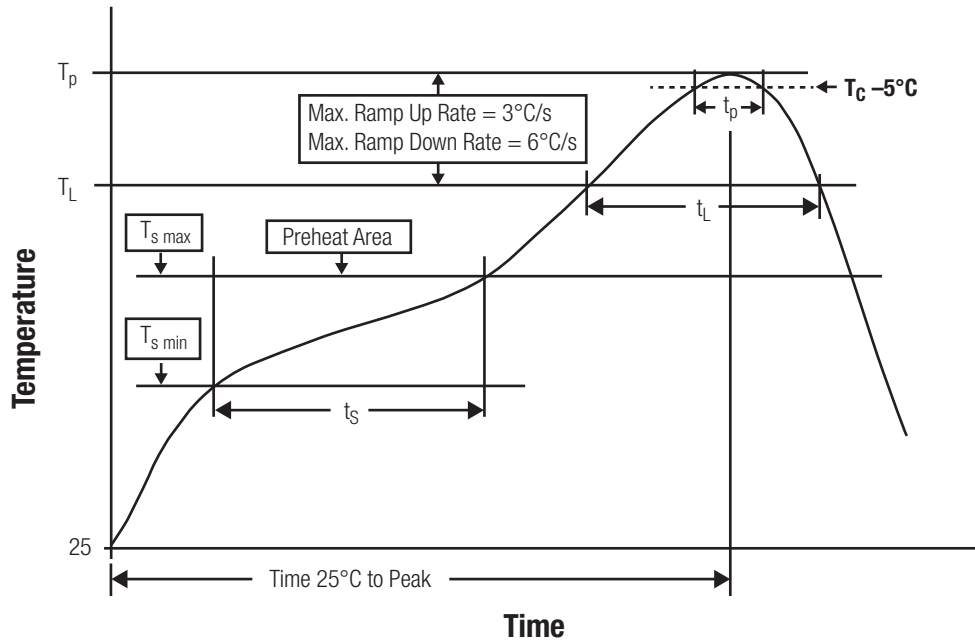
## Typical Inductance vs. Frequency Characteristics:




